



What is the Child Care Food Program?

The Child Care Food Program (CCFP) is a government program funded by the USDA, Food and Nutrition Services, and the California Department of Education that provides cash reimbursement to Family Child Care Providers (licensed/trustlined) for serving nutritious meals to children ages 0 to 12 yrs regardless of race, color, special needs, age, sex, or national origin.



What are the requirements to participate?

- ✓ Be a licensed or trustlined Family Child Care Provider residing in Alpine, El Dorado, Nevada, Placer, Sacramento, Yolo or Yuba County.
- ✓ Keep daily records of meals served to children using free online (www.minutemenu.com) or scan form system.
- ✓ Submit monthly records to Choices for Children (via internet or mail).
- ✓ Welcome visits from CCFP staff 3 times a year & attend annual training.

What are the benefits?



For Providers

- ✓ Monthly cash reimbursement (previous month is paid at the end of the current month).
- ✓ Federal & State rates are combined in each monthly check:

- ✓ Promotes healthful eating habits to last a lifetime.



For Parents

- ✓ Helps working families by providing substantial portion of children's food intake each day.
- ✓ Assurance that their children's diets are nutritious when away from home.
