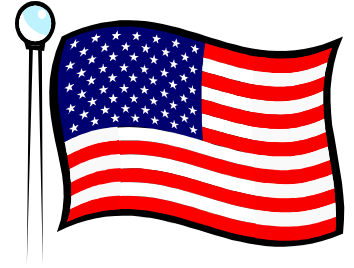

The Governor's May Revision Proposed to eliminate \$1.4 billion in General Funds of support for child care services and \$1.1 billion elimination of Cal WORKS.
